Introduction

ALLOS KOSMOS S.A. a company incorporated in Argentina, domiciled at Rigoyen Bernardo De 972, 7^{TH} floor, Suite A 1072- Autonomous city of Buenos Aires (**"OTRO MUNDO"** or **"We"**), respect your privacy and are committed to protecting it through our compliance with this policy.

This policy describes the types of information we may collect from you or that you may provide when you visit the website <u>https://www.otromundo.com.ar/</u> (our "**Website**") and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This policy applies to information we collect:

- On this Website.
- In email, text, and other electronic messages between you and this Website.
- Through our social media platforms, such as Tik Tok https://www.tiktok.com/@ser otromundo, Instagram: https://www.instagram.com/serotromundo/?hl=es, https://www.in stagram.com/bycrismorena/?hl=es, and YouTube https://www.youtube.com/@OtroMundoOK among others (our "Social Medial").
- Through mobile and desktop applications you download from this Website, which provide dedicated non-browser-based interaction between you and this Website.
- When you interact with our advertising and applications on third-party websites and services, if those applications or advertising include links to this policy.

It does not apply to information collected by:

• Any third party, including through any application or content (including advertising) that may link to or be accessible from or through the Website or Social Media.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and

practices, your choice is not to use our Website or Social Media. By accessing or using this Website or Social Media, you agree to this privacy policy. This policy may change from time to time (see Changes to Our Privacy Policy below). Children Under the Age of 16

Information We Collect About You and How We Collect It

We collect several types of information from and about users of our Website and Social Media, including information:

- By which you may be personally identified, such as name, last name, postal address, email address, telephone number, age, school, college, university, education institution, employer, or any other identifier by which you may be contacted online or offline ("**personal information**");
- That is about you but individually does not identify you, such as videos, reels, pictures, voice notes, and/or

We collect this information:

Information You Provide to Us

Information We Collect Through Automatic Data Collection Technologies

As you navigate through and interact with our Website and Social Media, we may use automatic **data** collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- Details of your visits to our Website and Social Media, including traffic **data**, location **data**, logs, and other communication **data** and the resources that you access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

We also may use these technologies to collect information about your online activities over time and across third-party websites or other online services (behavioral tracking). COPPA NOTICE: DIRECT NOTICE TO PARENTS

This COPPA NOTICE: Direct Notice to Parents ("COPPA Notice") gives parents additional information on the practices of **ALLOS KOSMOS S.A.** a company incorporated in Argentina, ("**OTRO MUNDO**" or the "Company"), in collecting and using personal information from children under 16 years of age with regard to the Company's web site and Social Media (the "Site").

The Company's Privacy Policy ("Privacy Policy") describe how the Site collects and uses personal information. In addition, the Site's use is governed by the Company's Terms of Use. You can review the Terms of Use and Privacy Policy on any of the hyperlinks above, or by navigating to the Site at <u>https://www.otromundo.com.ar/</u> and clicking on the words "Terms of Use," and "Privacy Policy".

Who operates the Site?

The Company developed and operates the Site as an interactive web site for the formation and preparation of Artists. Certain companies including, but not limited to, internet and public relations service providers (collectively, "Service Providers") may assist the Company with respect to its web sites. The Company is the sponsor of the Site. Service Providers may provide other services, such as technical support, or analyze the performance of the Site.

What information does the Site collect and use?

Certain nonpersonal information about visits to the Site is recorded by the standard operation of the internet servers on which the Site is hosted. The nonpersonal information that we collect may include IP addresses, the type of operating system in use (e.g., Android or Windows), the type of browser being used by the visitor (e.g., Internet Explorer or Firefox), the number and frequency of visitors to the Site, and the site the visitor was on immediately before visiting the Site. The Company may collect certain nonpersonal information from children by using small text files known as cookies.

We use cookies for several purposes, such as to recognize visitors to our web sites, to determine the number of unique visitors to our web sites, to ascertain which

web site pages they visit, and to conduct internal reviews of our site. You are always free to decline cookies, but in doing so your child may not be able to use certain features on our web sites. In connection with the Site, The Company also collects certain personally identifiable information about your child, including first and last name, date of birth, gender, address and email address, parent's (or guardian's) first and last name, mailing address, phone number, date of birth, gender and email address. Personally identifiable information of children under 16 is only collected with parental consent, and if the Company becomes aware of a child under the age of 16 providing personal without parental consent, we will attempt to delete that information.

How does the Site collect this information?

As described in the Privacy Policy and Children's Privacy Policy, to permit your child to create an account and register with the Site, The Company requires you to complete, sign and return the Parental Consent Form attached to this COPPA Notice (the <u>"Parental Consent Form"</u>. After you have returned the Parental Consent Form, which includes the child's first name, last name, date of birth, gender and email address, education institution, the child is enrolled as a member and will be contacted via email at the address provided in the Parental Consent Form (or at the parent/guardian's address, if no email address is provided for the child).

We may then obtain additional information, including personally identifiable information, to supplement the information provided by you in this Parental Consent Form. As described in the Company's Privacy Policy and above, the Site may also use cookies to enable your child to sign in, to help personalize the Site, and to help the Company administer the Site.

How will the Site use this information?

The Site uses the personally identifiable information provided by the parents and children for this purpose:

- To present our Site and its contents to its visitor.
- To provide information, products, or services that visitors request from the Company.
- To provide visitors with notices about their account/subscription, including expiration and renewal notices.

- To notify visitor about changes to the Site or any products or services offered or provide though them.
- To allow visitors to participate in interactive features on the Company's Site.
- In any other way the Company may describe when visitors provide the information.
- For any other purpose with visitor's consent.

Does the Site share this information with any third parties?

The Site only uses personally identifiable information about children for internal operating purposes and does not share personal information received from parents or children about children with third parties, except as required to run the internal operations of the Site, in response to judicial process, to comply with legal requirements, and, as permitted under provisions of law to provide information to law enforcement agencies, in connection with an investigation on a matter related to public safety, or as permitted by law to protect our rights or property, the Site, or its users.

The Company may transfer or otherwise disclose certain nonpersonal information it collects from children or parents to shareholders, employees and independent contractors of the Company, its subsidiaries, affiliates, and internet and public relations service providers if the disclosure will enable that party to perform a business, professional, or technical support function for the Company, or if required to do so by law.

Any such information shall be stripped of any personally identifying characteristics, and the Company will not share personal information such as the child's first and last name, the child's address, the child's email address, the child's telephone number, the child's persistent identifier associated with individually identifiable information, or any information collected from the child that is combined with a persistent identifier.

While the Company takes measures to ensure the confidentiality of personal information collected from children, the entities to whom personal and nonpersonal information may be disclosed are not subject to any formal confidentiality requirement.

How does the Site get consent from parents for the collection of personal information?

To create an account on the Company Site or interact in any way with the Site, a parent or guardian must complete, sign and return the <u>Parental Consent Form</u>, in which the parent or guardian: (a) provides information about the parent and his/her child; (b) consents and agrees to follow the Site's Terms of Use; and (c) consents to the Site's practices in collecting and using personal information from children under 16 years of age as specified in the Privacy Policy, and this COPPA Notice.

A parent's or guardian's affirmative consent, as evidenced by a completed and signed Consent Form, means that such parent or guardian consents to the collection, use and disclosure of the personally identifiable information of his or her child in accordance with this COPPA Notice, the Privacy Policy and the Company's Terms of Use.

<u>Can a parent review, change or delete the information collected by the Site</u> <u>about his or her child?</u>

A parent can at any time review or change the information collected by the Site about his or her child by contacting the Site. Parents or guardians may consent to the collection and use of their child's personal information without consenting to the disclosure of that information to third parties. A parent or guardian can also refuse to permit the Site to collect any further personal information and can request that the Site delete any information already collected.
